The meeting shall commence from 4.00 PM in the evening, followed by cocktail and dinner. You are requested to kindly send your consent to attend the meeting, so that we may arrange food and other arrangements so that wastage may be minimized. Once again I urge that this meeting is very important for the future of Pharma industry in small scale sector.

There are few important issues, reply of these important issues have to be submitted promptly within 4 days. The issues are mentioned below:

- Central Government has started a new move i.e. to give directions to all Doctors whether Government employed or Private Doctors to prescribe only generic medicines. This is another blow to ruin the future of Pharma industry and will lead to substandard medicines to be flooded in the market.
- 2. As you are aware that Ministry of Health has issued a notification GSR 327 (E) dated 03.04.2017. In the said notification, Ministry of Health has incorporated in Rule 74, 74B, 76, 78, 78A i.e. at the time of grant of any license for oral dosage form, bioequivalence should be submitted along with the other documents for drugs specified under category of II & IV of Biopharmaceutical Classification System (BCS). Copy of this notification and list of drugs in BCS are enclosed with this letter as Annexure 1 & 2 respectively. We need your advice on this issue.
- 3. Ministry of Health and Family Welfare issued a notification GSR 319 (E) dated 31.03.2017. In the said

Goa Pharmaceutical Mfrs. Association, Mapusa - 403526 draft rules, Ministry of Health has proposed manufacturing License of Pharmaceutical products, Retail sale license, Wholesale License etc. to be issued or already issued, not for 5 years but forever. On the other side they proposed that manufacturing units at the time of grant of License and every year, shall be inspected by Central and State Authorities and verification of defects raised by the Inspecting team shall also be done by the Joint team of State and Central Authority. Copy of notification (draft rules) is enclosed as Annexure 3. We need your advice within a period of 7 days as we have to submit the objection on or before 15.05.2017.

I cordially invite members from the Pharmaceutical industry, even if they are not in the list of office bearers of CIPI.
